

PROGRAMS WITH SPECIAL CONDITIONS AND CONDITIONS THAT MUST BE MET

Demirözü Vocational School Department of Transportation Services Civil Aviation Cabin Services

- 1) Not have a criminal record or criminal archive record.
- 2) 160-180 cm height requirement for women (weight requirement is 5 kg more than of height or 15 kg less than the last two digits of height).
- 3) 170-190 cm height requirement for men (weight requirement is 5 kg more than of height or 15 kg less than the last two digits of height).
- 4) Health condition must be flightworthy (Candidates are required to receive a report from health institutions authorized by the General Directorate of Civil Aviation about their health condition is flightworthy).
- 5) No tattoos or scars etc. on the visible parts of the body when wearing the cabin crew uniform.

Demirözü Vocational School Department of Transportation Services Civil Aviation Transportation Management

- 1) Not have any criminal record or criminal archive record that prevent candidates from getting an airport entrance card.
- 2) Receiving a committee report from full-fledged hospital in the last 6 months stating that there is no health problem that will prevent candidates from the occupation and/or performing the task given in the occupation (absence/loss of hearing, absence/loss of vision etc.)

Vocational School of Technical Sciences Department of Reservation of Ownership Private Security and Protection

- 1) Not be sentenced for one year or more prison term for an purposely committed crime.
- 2) Not be sentenced of crimes against the security of the State, the constitutional order and the functioning of this order, private life and the right to privacy, sexual inviolability and crimes related with drugs and stimulants, embezzlement, perpetration, bribery, robbery, fraud, forgery, abuse of trust, fraudulent bankruptcy, collusive tendering, offence of using fraud or trickery in the fulfillment of execution, laundering the property obtain from crimes, smuggling and prostitution even if pardoned.
- 3) Not have any ongoing investigation or prosecution for crimes against the constitutional order and the functioning of this order, private life and the right to privacy, sexual inviolability and crimes related with drugs and stimulants.
- 4) Not have any physical and mental illness or disability that may prevent the candidate from execute of the job.
- 5) Candidates required to receive a health report with the expression that "Can be a private security officer" from hospital or sufficient health institutions. In that report that must be these conditions;
 - a) Psychiatry: Not have any psychiatric illness or personality disorder (psychopathia) and alcohol and drug addiction,
 - b) Neurology: Not have any neurological illness that may prevent the candidate from execute private security service,
 - c) Eye: Not have blindness or night blindness,
 - d) Otorhinolaryngology: Not have any loss of hearing that may prevent the candidate from execute private security service.
